## **COVID Initial Opening Riding Rules and Format**

In order to provide access to the Grande Prairie Motocross Association during this period of limited business operations caused by COVID-19 restrictions, GPMA must impose a strict format to comply with our understanding of Alberta Health Orders and Directives. We recognize these new regulations may not be pleasant but access to the facility during a pandemic is a privilege and we need to ensure transmission risk at the facility is minimized and that the Club does its part to maintain strict standards as may be imposed by Alberta health and welfare authorities.

We look forward to the relaxation of these rules when restrictions are eased but for now, to ride you must comply with the following:

### **Membership**

- All riders must purchase and be in possession of a valid 2021 GPMA membership.
- Day Passes not available at this time.

### **Schedule**

- The Executive of the Grande Prairie Motocross Association has the right to set, alter, or change the operating hours of the track at any time and without notice.
- We will post opening times on our website and Facebook. If there is any doubt, please reach us on Facebook to confirm.

### **Parking**

- There will be outlined parking spots to ensure proper distancing.
- You may not switch parking spots.
- You may not park anywhere else than the outlined areas.
- All spots are assigned on a first come, first serve basis and in order of when you arrive to the track.

### **Physical Distancing**

- Riders are not permitted to engage in social conversation at others parking spots.
- Physical distancing of at least 2m is required and will be mandated at all times.
- It is expected that you are either at your parking spot, or riding.
- It is expected that everyone on the premises will act in accordance to the COVID-19 guidelines set out by Alberta Health. By becoming a member and user of the facility you are agreeing that you have read and understand these rules and will adhere to them as well as all Alberta Health guidelines currently in place.
- Failure to comply with the above will result in a 1-month suspension of riding and/or revoking of all riding privileges, or, at the discretion of the Board of Directors, termination of membership.
